Set-Up/Break-Down:

Set-up will take place on Friday April 9th from 9:00 AM to 3:00 PM. All artists must be completely set up by 12:00 PM to allow the health department to complete their inspections before we open the doors at 4:00 PM. For your convenience, you may use the loading dock located at the back of the convention center once you have obtained a dock pass from the Bear Lot. Vendors with trailers can park in Mohegan Sun's parking lot for FREE.

Included With Your Booth Reservation & Important Info:

- Each booth rented includes: 10'x10' space, (2) vendor passes, (2) tables, and (2) chairs.
- All booth reservations are guaranteed & final on a first come, first serve basis, with payment in FULL.
- Additional 3-day passes are \$40.00ea. if payment is included with contract or \$50.00ea. at door.
- Additional tables can be rented at the event from Demers Expo Services.
- Medical waste removal is provided by Tommy's Supplies.
